It is true, that in the ordinary cases where a power is given for a certain time, to wit, "from the first day of the month next following," it would be presumed that it was meant to last until the end of the month, but, where the language used was not for a certain time, but for the duration of the Trust, it was not necessary to mean that the power should continue until the end of that time. If the object of the Trustees was to use it, in connection with their general powers, to extend or shorten their meetings at their own pleasure, there could be no objection, and, if there was such a mutual intention, the absence of such words, would be supplied by implication. A trust will not be presumed to be executed by a public officer, but is to be construed strictly against him; and this, no doubt, is the reason why it was held, in the case of *Avery v. The Chance Company*, 2 Wall. 190, that the State, in creating a corporation, must express its intention that it shall be liable for the acts of all of its officers. If the Trustees in the case before us had, in the act of incorporation, expressed their intention to use the property as a public corporation for the purpose of dealing in the same manner as other public corporations and to be subject to the liabilities of such a corporation, they would have been liable for the acts of their agents.
